Eliot Spitzer introduced a bill to the New York State Legislature (S.5829/S.6045) which, among other issues against life, would mandate Catholic Hospitals and institutions perform abortions and require the Catholic Church in NYS to provide medical insurance for the procedure, in violation of Freedom of Religion and the Separation of Church and The founding fathers of our country experienced, firsthand, the disastrous results of civil government interfering with the rights of religious consciences in Europe. The Separation clause, if anything, was meant to avoid the replication of such a situation in the new nation. Unfortunately, his successor, Gov. David Paterson, is also pro-abortion and the matter has not died with the last administration. Non-Embryonic Stem Cells

Life magazine ran a series on fetal life, showing the babies in different stages of development. The Supreme Court of the United States ruled in Roe v. Wade that they did not have a right to life. That led to controversy and in some cases violence. Now we have embryos and the embryonic stem cell. The fetus (baby) cannot speak. The stem cell is genderless. Both are totally defenseless. The reason for the use of stem cells is to repair body parts and cells. They can fix leukemia, repair a heart valve, and make muscles work again. As a result there is a moral quandary in our immoral society. That is the creation of embryonic stem cells.

The Hollywood hype is that we are denying cripples and other people with illnesses of their chance to recover. This is the furthest thing from the truth. Stem cells that have been derived from aborted babies have had no success. Yet, those derived from body parts etc. have been successful in curing people. This other evil needs to be stopped with regulation, but it can only be stopped with your spiritual study of the subject, to eventually make you realize the horror of what is being perpetrated on humans with potential. There has been a powerful breakthrough in the scientific community which pursues stem cell research that does not use embryos. They are derived from skin cells. This is very exciting news. ### A Candidate New to the Scene: Barack Hussein Obama

A brief look at the statements Barack Obama has made on life issues and marriage shows that his beliefs are out of line with the teachings of the Church:

- ♦ In 2003, while chairman of the Illinois Senate's Health and Human Services Committee, Obama led the fight to oppose a bill that would have mandated healthcare for a baby who survived an abortion, effectively legalizing selective infanticide.
- ♦ During a recent appearance in Johnston, PA, after a woman in the audience made a plea for him to help "stop these abortions," Obama said of his daughters, "...if they make a mistake, I don't want them to be punished with a baby."
- ♦ On March 2nd, Obama told a crowd at Hocking College in Nelson-ville, OH, that he believes the Sermon on the Mount justifies his support for the legal recognition of same-sex unions, and at the same time referred to St. Paul's Epistle to the Romans condemning homosexuality as "an obscure passage in Romans."

Yet, somehow Obama claims that all of his positions are in harmony with Christian teaching.

#### A Prayer from Archbishop Sheen

Archbishop Fulton J. Sheen asked us to say this prayer every day: "Jesus, Mary, and Joseph, I love you very much. I beg you to spare the life of the unborn baby who I've spiritually adopted, [Name], who is in danger of abortion. You can add after the prayer: "Our Lady of Guadalupe, pray for us.
