

Reporter: Mother, do you think it is possible for some common ground to be found between the Pro-Life people and the Pro-Abortion people?

#### A Memo to the President

President Obama was just sworn in as President when a pro-abortion advocacy group submitted a fifty-five page memorandum to the Obama transition team explaining in detail policy changes they recommend. The memo contained policies the group said should be taken within the first 100 days of the new administration. One plan: restoration of federal funding to organizations that promote abortion overseas (this was done within four days of Obama's inauguration.)

Within 100 days the group wants to see elimination of the Hyde amendment, which prohibits funding of Medicaid abortions. The memo also details policy goals they want realized in the next four years, including the Freedom of Choice Act. FOCA prohibits any level of government from enforcing any policy that would limit access to abortion! This would force Catholic hospitals to perform abortions or close. Doctors and nurses would not be able to opt out based on conscience. This is in the process of being enacted right now.

Under FOCA there would be no health regulations in regards to abortions. Any health care provider would be allowed to perform abortions. Taxpayers would fund abortions. Time limits for killing unborn babies would

be done away with. Parents would lose their rights to be informed of a daughter's intent to have an abortion and parental approval would not be required. Barack Obama promised that, "...the first thing I'd do as President is sign FOCA." The Freedom of Choice Act would supercede Partial Birth Abortion as the worst and final free-for-all against life, no restrictions, no time limits.

Five senators, who claim to be Catholic, are among those sponsoring this legislation in the Senate:

John Kerry (D-MA), Barbara Mikulski (D-MD), Bob Menendez (D-NJ), Patty Murray (D-WA), and Maria Cantwell (D-WA). Please contact them and remind them that you can't be Catholic and pro-abortion. Also, contact your legislators and let them know your feelings.

Keep in mind that Congress may try to attach FOCA to other legislation by writing it at or near the end of the bill, where they believe it will not be noticed.

A couple of Post Offices in Texas have been forced to take down small posters that say "In God We Trust." They say the law is being violated. Hey, that's our country's motto! 86% of Americans believe in God. Can it be that WE need to take action and tell the 14% to quiet down? #### Catholics for Obama

54% of Catholics voted for Obama — shocking, but just as shocking is the lack of leadership from our Catholic Bishops! The U.S. Conference of Catholic Bishops has given more than \$7.3 million to Acorn over the past decade for about 320 projects. In June, the Catholic Church froze a \$1.2 million grant for 38 Acorn chapters after the group was accused of voter fraud in 15 states.

An example of Acorn at work: the group was paid \$406,730 by the United Federation of Teachers to help the union organize 28,000 child care providers. Earlier this month Acorn also helped organize protests against the phase out of P.S. 194 in Harlem to make way for a charter school! The Education Dept. eventually caved and the public school will not be closed (even though charter schools have been quite successful in improving education in minority communities.)

According to Ralph McCloud, the new executive director for CCHD (Catholic Campaign for Human Development), all applications go through rigorous screening and each organization is asked to commit to being non-partisan. He has got to be kidding! With a click of the computer, one can quickly discover Acorn's radical agenda dating back to 1995. We Catholics are sadly in need of better leadership from our Bishops!

#### Pastoral Silence

The thought of another pro-abortion government in power is discouraging. It is even more discouraging when one sees that Catholics had a very significant effect in the elevation of the pro-abortionist candidates, 54% of Catholics having voted for the infanticide supporters. Obviously, the rank and file of the pro-life believers have a lot of work to do to change the voting attitudes of those Catholics who have compromised the tenets of

the Church in the public square.

There is evidence that some bishops are beginning to confront Catholic politicians who consistently vote in favor of legislation to support abortion. Whether those bishops will truly persist remains to be seen. But until clerics continue to counter pro-choice claims made by high-profile Catholics, faithful Catholics will remain bewildered by pastoral silence.

have a stranglehold on the minds of a generation of students, molding them toward their on political views on civil rights, homosexuality, global warming, and abortion. These views include socialism, materialism, and dictatorship. Does the reader begin to get the picture now? Reading the Mindzenty Report newsletter informs us that only 15% of American colleges are conservative and over 70% are liberal.

Some names we the reader should be aware of are Bill Ayers, his wife Bernadine Dohrn, from Northwestern University, and Ward Churchill, a former Colorado professor.

Parents must seek colleges with Catholic values such as Thomas More in New Hampshire, Ave Maria in Florida, Christendom in Virginia, and Franciscan University in Ohio. At each site local bishops must rule on its Catholicity. We all see the results that the education today is driving students to Godlessness, destroying our great country, and is not a win situation. #### Catholics Called to Action

Recently, two Connecticut State Senators attempted to fast-track a bill (Bill 1098), "An Act Modifying Corporate Law Relating to Certain Religious Corporations", that would give the state the power to intrude into the internal affairs of the Church. Not surprisingly, this bill targeted only one church — the Catholic Church. This blatant attempt to meddle in the affairs of the Church would have, if successful, changed the way in which the Church governs itself and given unjustified power to the The passionate response of 4,500 citizens expressing their objection to this bigoted bill was heard loud and clear. The fight is not over. Many fear that the legislature will be used to punish and harass the Church for its consistent and courageous stand against embryonic stem cell research, gay marriage, abortion and other issues. This bill was a direct attack on the leadership, both clergy and laity, of our Church. That two state senators would even think they had the right to propose laws to change the internal structure of the Catholic Church, or any other church, is chilling.

Catholics need to accept the reality that our Church is under attack and we need to find the courage to respond quickly and clearly in her defense. We have seen our faith demeaned in the movies, in TV series, by late night comics, etc. Great care is taken not to offend other religions. It appears that the Catholic Church, her clergy, and beliefs are safe ground for any type of disrespectful attack. We have been silent too long. The voices of 4,500 Connecticut protestors were heard loud and clear. Our voices must be heard whenever our Church is attacked.

#### The "Give Act"

The Mandatory Youth Services Bill (HR 1388) has been passed in D.C. The purpose of the bill is to require mandatory volunteer service through AmeriCorps, even though Fox News believes the legislation could cost up to \$6 billion over 5 years. AmeriCorps volunteers have a history of being employed by community programs including Planned Parenthood. Volunteers could end up counseling P.P. clients to recommend and arrange abortions. It is uncertain whether participants can work in Acorn.

As a presidential candidate, Obama promised a national service program closely allied with the non-profit sector. In other words, he wants to fund America's youth into volunteer work alongside the likes of Acorn. Obama's favorite community organizers may soon be training your children. Obama and Biden hope to expand AmeriCorps and the Peace Corps with a goal that all middle and high school students do 50 hrs. of service a year and will establish a tax credit worth \$4,000 in exchange for 100 hrs. of public service per year. Let's hope that our military personnel will be included in the bonanza. They are all volunteers!
